## **Memory Care Placement**

Medicare does not cover memory care placement. For financial assistance to pay for care, an application for Special Assistance Medicaid needs to be completed at social services in the county the individual resides.

Effective January 1, 2025, the monthly Enhanced Rate for Special Assistance is \$1,832.50 (this means the individual cannot receive more than max countable income: \$1,832.50 monthly to receive Special Assistance)

  - TOTAL: \$1,833
  - Max Countable Income: \$1,832.50 (due to rounding)

Adult Care Home FL2 Form provides diagnoses, what level of care is needed, and medications. Facilities review the Fl-2 to determine if their facility is the appropriate fit for care.
